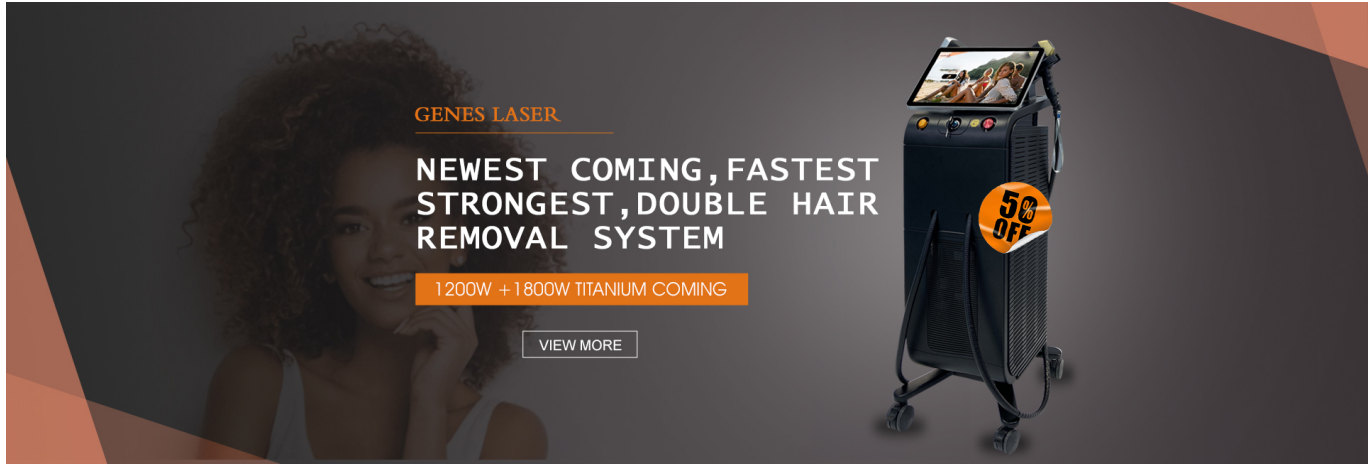

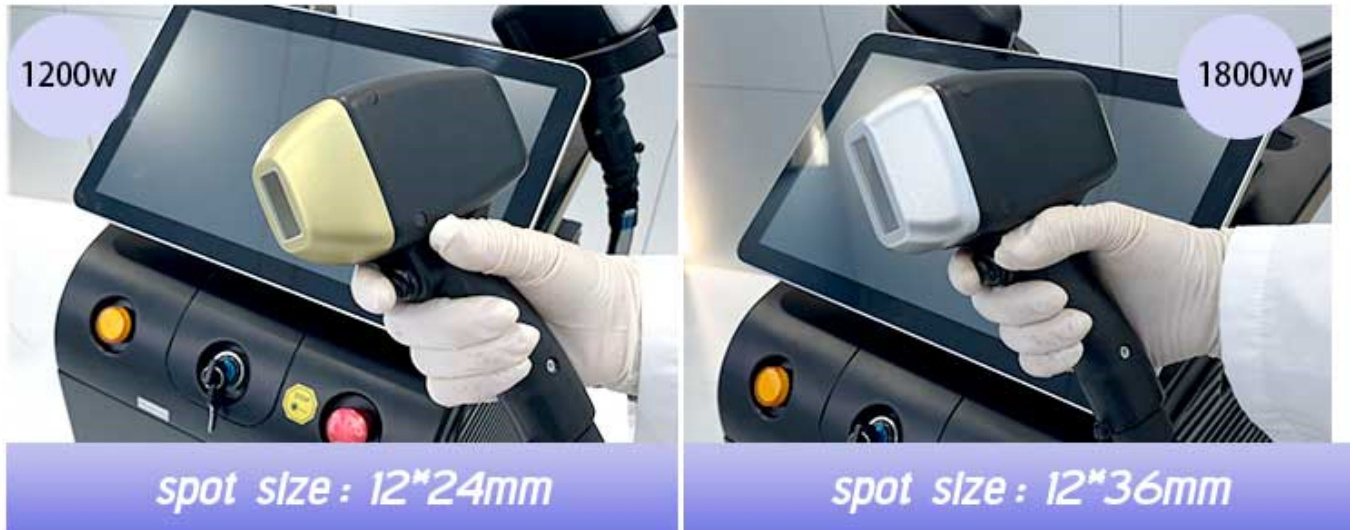

- The handle has a cooling effect that improve treatment comfort.



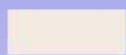

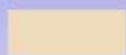

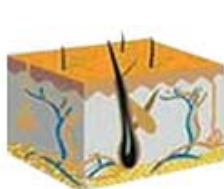

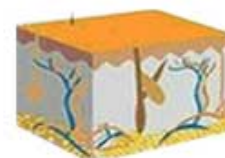

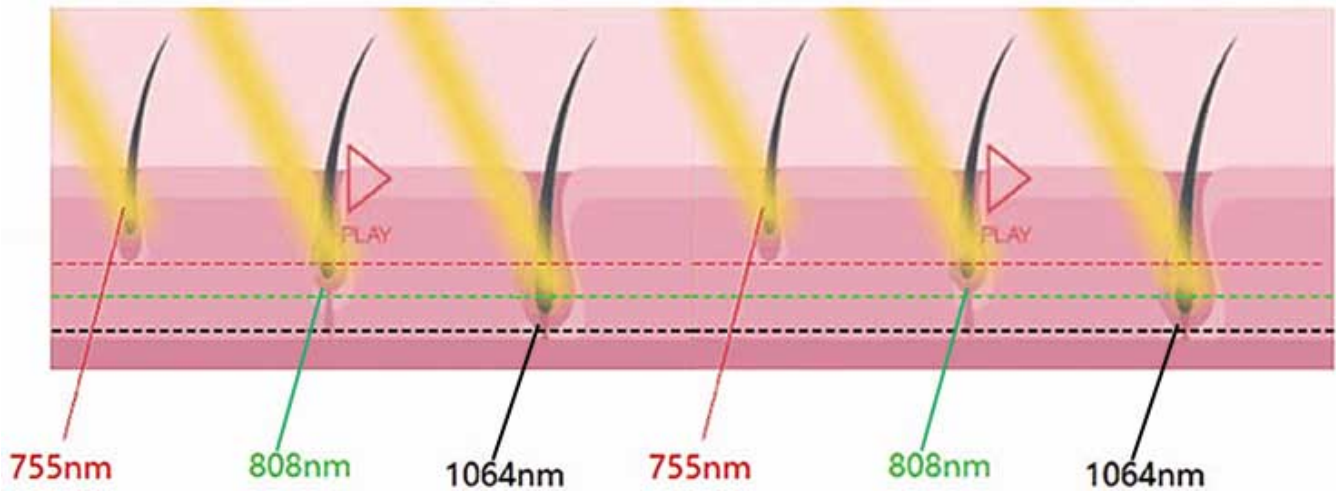

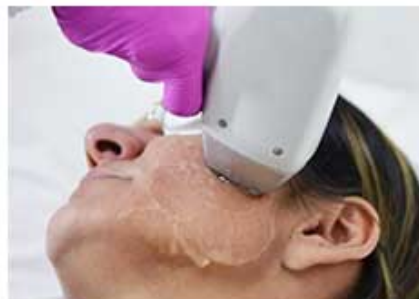
Triple wavelength laser spots work together
